# APRIL, 2014 VW FOOD SECURITY COLLECTIVE REPORT

On Saturday, April 5, the Mason Bee barn was installed in the Orchard by bee expert Gord Hutching of Hutching Bee Service. This was a component in the approved Orchard project proposal. Mason bees are a native species that do not sting or make honey.

The barn serves to attract pollinators and as an educational element in the Orchard. It contains a large main house with multiple fixed trays and a secondary smaller house with removable trays so the public can observe the bee cocoons or see the bees building mud plugs and laying eggs.

A local resident has offered a donation to cover the cost of the installation: an invoice will be submitted soon and the Food Security Collective coordinator will be contacting the donor to acquire the funds.

There has been discussion with the local Girl Guides for their members to act as the bee stewards. (Hives require cleaning each year to prevent mite infestation.)

On Sunday, April 6, the Food Security Collective hosted a well-attended Community Potluck. Folks came from around the neighbourhood as well as some from Esquimalt. We opened the new folding wall and enjoyed the space created when the Fireplace Room and foyer are joined. Keith Banfield, grandson of the man for whom Banfield Park and Alderman Road are named, joined us: Keith is 79 years old and lives on Lampson Street. (His grandfather was the first city alderman representing Victoria West and was also acting mayor for a time.)

VICTORIA, BC – Three strategic sites are the focus of the City's upcoming engagement on the Inner Harbour: Belleville Terminal; Ship Point and Lower Wharf Street.

Public feedback will be used to help develop guiding principles and development concepts for each site which will help guide and evaluate future development. These principles and concepts will also help to better position the City of Victoria and other Inner Harbour land owners for potential capital funding, grants and development opportunities. The overall process will be framed and informed by existing City plans, policies, regulations and related technical studies.

"We are looking forward to hearing the community's ideas on how we can enhance these key sites in our Inner Harbour," says Mayor Dean Fortin.

The City of Victoria is undertaking this public engagement process to identify opportunities for improving the vitality of the Inner Harbour, which is a key objective of several Council-approved policies and plans. These policies and plans share the following common objectives that will guide dialogue with the public and the overall planning process:

- Supporting Waterfront and Harbour revitalization
- Enhancing tourism
- Ensuring sensitivity to the surrounding historic and waterfront context
- Maintaining a working harbour
- Completing the Harbour Pathway (David Foster Way)
- Maintaining and enhancing the Harbour's important role for marine transportation and as a gateway to the city, region and Vancouver Island
- Providing well-designed and appropriate public realm improvements

There are a number of opportunities for public participation. The Harbour Dialogue Open House on Friday, May 9, 3:00 p.m. – 7:00 p.m. at Ship Point is an initial opportunity to drop-in to view project information, talk to City staff and provide ideas for the three sites. Representatives from Tourism Victoria, Greater Victoria Harbour Authority, Downtown Victoria Business Association and the Royal BC Museum will also be in attendance.

The Ideas Forum on Saturday, May 10, 10:00 a.m. - 3:00 p.m. at the Victoria Conference Centre is an opportunity to participate in interactive discussions that explore questions related to the three sites. Two separate two hour sessions will be held during the Ideas Forum at 10:00 a.m. and at 1:00 p.m. Preregistration is required: harbourdialogue@victoria.ca
