\$20,000 for capital costs relating to the child care space in two new buildings on the Vic West Elementary School field, recent negotiation with SD61 indicate that they are over budget on the project in relation to the Province of BC grant and would not have sufficient funds to cover the child care operating capital requirements, they have guaranteed to provide \$30,000 from district funds if the VWCA covered the balance.
